The kind you never hear -- educators and the media don't want you to.

DR. ROBERT A. MILLIKAN, a famous physicist and Nobel prize winner, said, “Everyone who reflects believes in God” [Millikan, Robert A., *The Commentator*, June, 1937]. In an address to the American Chemical Society, he said, “The pathetic thing about it is that many scientists are trying to prove the doctrine of evolution, which no scientist can do.”

LOREN EISLEY, a leading evolutionist, said, “With the failure of these many efforts, science was left in the somewhat embarrassing position of having to postulate theories of living origins which it could not demonstrate. After having chided the theologian for his reliance on myth and miracle, science found itself in the unenviable position of having to create a mythology of its own: namely, the assumption that what, after long effort could not be proved to take place today, had in truth taken place in the primeval past” [Eisley, Loren, *The Immense Journey*, Random House, New York, 1957, page 199].

DR. D. M. S. WATSON wrote, “The theory of evolution itself is a theory universally accepted, not because it can be proved by logically coherent evidence to be true, but because the only alternative is special creation, which is clearly incredible” [Watson, D. M. S., “Adaptation,” *Nature*, Vol. 124, 1929, page 233].

DR. W. R. THOMPSON, a world renowned entomologist, was for many years the director of the Commonwealth Institute of Biological Control at Ottawa, Canada, and was selected to write the foreword to the new edition of Darwin's *Origin of Species*. In that foreword he made the following very significant statement: “As we know, there is a great divergence of opinion among biologists, not only about the causes of evolution but even about the actual process. This divergence exists because the evidence is unsatisfactory and does not permit any certain conclusion. It is therefore right and proper to draw the attention of the non-scientific public to the disagreements about evolution. But some recent remarks of evolutionists show that they think this is unreasonable. This situation where men rally to the defense of a doctrine they are unable to define scientifically, much less demonstrate with scientific rigor, attempting to maintain its credit with the public by the suppression of criticism and the elimination of difficulties, is abnormal and undesirable in science” [Thompson, W. R., “Introduction,” *Origin of Species*, by Darwin, E. P. Dutton & Co., New York, 1956].

DR. GEORGE WALD, a Nobel prize winner, chooses to believe in evolution even though he regards it as a scientific impossibility. He says, “The only alternative to a spontaneous generation is a belief in supernatural creation ...” [Wald, George, “Innovation and Biology,” *Scientific American*, Vol. 199, Sept. 1958].

FRED JOHN MELDAU wrote, “In nature we find endless variety within the species of genus; but absolutely **NO CHANGE** from one family to another. Summed up in four words, the laws governing all life prove there are **MUTATIONS BUT NO TRANSMUTATION**, which simply means that there are many varieties within any group, but there can never be one ‘kind’ of life mutating (changing) into another family” [*Witness Against Evolution*].

PROFESSOR T. H. MORGAN said, “Within the period of human history we do not know of a single instance of the transformation of one species into another” [Morgan, T. H., *Evolution and Adaptation*, page 43]. [Should anyone be inclined to quibble over his use of the word “species,” just go back to the previous quotation. -BC]
